## LIMITATIONS

- Dealer is limited to (1) per SKU. Maximum of 10 guns in total.
- Dealer must be currently stocking POF-USA Firearms.

## RANGE RENTAL WARRANTY INFORMATION

- All POF-USA Range Rental firearms are covered by a limited lifetime warranty while in service.
- All firearms being returned for warranty service must be returned to POF-USA Warranty Department. Please contact POF-USA Warranty Dept. directly for Return Authorization:

- All ammunition used in POF-USA Range Rental firearms must be new, non-remanufactured ammunition. The use of reloaded or remanufactured ammunition will void the stated lifetime warranty.
- After one year period is up, dealer may send firearms into POF-USA to be refurbished into a good working condition to sell as a used gun. Cost of refurbishing will be evaluated upon condition of the firearms.

# TERMS & CONDITIONS

1. This Program is available only to qualified Range Operators and is void where prohibited by law. POF-USA reserves the right to change any terms of this Program at any time, or cancel this Program at any time.
2. In order to qualify for continued participation in the Program, Range Operator must maintain a physical retail store as well as an on-site firing range, and fulfill the obligations set forth below as determined by POF-USA in its sole discretion.
3. For so long as Range Operator qualifies for participation in the Program, Range Operator may order a minimum of two (2) POF-USA firearms every twelve (12) months within a calendar year. No more than one (1) of any individual SKU or a total of ten (10) firearms may be ordered via the program.
4. All POF-USA Range Guns must be available for use as public range firearms at (the address set forth below) for a minimum of twelve (12) months. Range Operator is responsible for maintaining the POF-USA Range Guns in proper working order in accordance with all instructions in the accompanying Safety & Instruction Manuals. The POF-USA Range Guns shall not be sold within this twelve (12)-month period. All POF-USA firearms sold through the Range Program come with a limited lifetime warranty. This warranty is limited and does not extend to careless handling, abuse and misuse, unauthorized adjustments or modifications, use of improper ammunition, unreasonable use, rust or corrosion or barrel obstruction. POF-USA Range Guns may not be transferred to any other location of Range Operator than the location identified at the bottom of these Terms and Conditions.
5. Orders for POF-USA Range Guns will be processed by a POF-USA Distributor of the Range Operator's choice, and such orders may be subject to additional terms and conditions of the Distributor. All orders will be drop shipped to the Range Operator at the address listed on its FFL from the preferred distributor. Program orders will be billed at current POF-USA Range Program pricing which is updated and published from time to time. Range Operator understands and agrees that it is responsible for any applicable state sales taxes due for the purchase and use of any POF-USA Range Guns purchased under this Program.
6. Range Operator is solely responsible for ensuring that the POF-USA Range Guns ordered under this program are lawful and compliant in the jurisdiction of the Range Operator's facility.
7. Range Operator agrees to comply with all applicable laws and regulations concerning the use and sale of POF-USA Range Guns. Range Operator further agrees to adhere to and enforce the highest standards of firearm safety at all times, including the use of appropriate eye and hearing protection while the range is in use. Range Operator agrees to be solely liable for violation of this paragraph. The provisions of this paragraph cannot be waived.
8. Range Operator agrees to use only commercially manufactured ammunition with internal ballistic pressures which are in strict accordance with the specifications of the Sporting Arms and Ammunition Manufacturers' Institute (SAAMI) in the POF-USA Range Guns. Violation of this paragraph may void the POF-USA standard warranty on the POF-USA Range Guns, and subject Range Operator to replacement at full price.

9. POF-USA trademarks, including the POF-USA logo, are the property of POF-USA and may not be used without prior authorization in writing from an authorized representative of POF-USA. POF-USA will provide authorized POS display materials for range enhancement and any alteration or modification of these materials or unauthorized use of any POF-USA trademarks or logos (including the use of a POF-USA trademark in a domain name) is strictly prohibited and may preclude Range Operator from further participation in the Program. Moreover, the use and goodwill associated with any use of the POF-USA trademarks by the Range Operator shall inure to the benefit of POF-USA. POF-USA reserves the right to audit the use of the POF-USA trademarks by the Range Operator at any time.
10. Range Operator agrees that POF-USA Distributors and/or POF-USA agents may conduct, without notice, random periodic inspections of the POF-USA Range Guns purchased through the term of the Program.
11. Range Operator will not sell any POF-USA Range Guns purchased via the Program within the initial twelve-month period specified above.
12. Range Operator agrees to defend, indemnify and hold POF-USA, its parents, affiliates, agents and employees harmless, from and against any and all claims and causes of action, damages, losses, liabilities and expenses (including reasonable attorney's fees) arising out of or relating to Range Operator's participation in the Program, including without limitation the use and/or misuse of the POF-USA Range Guns purchased under the terms of the Program. Use and/or misuse includes but is not limited to use of improperly reloaded or re manufactured ammunition in the POF-USA Range Guns, and/or operating an unsafe range.
13. The participation of Range Operator in this Program shall begin on the last date these Program Terms and Conditions are signed by its authorized representative and are approved by an authorized POF-USA representative. The Program shall remain in effect until terminated or changed by POF-USA, at its sole discretion. Range Operator must remain in this Program for at least twelve (12) months following the receipt of any POF-USA Range Guns.
14. These Terms and Conditions as amended or revised from time to time contain the entire agreement between the parties with respect to the Program. Range Operator acknowledges that POF-USA may amend or revise these terms and conditions from time to time without notice. No other terms and conditions shall be binding on POF-USA. Should any of these terms and conditions be interpreted or adjudicated by a controlling authority to be unenforceable or to violate public policy, all other portions shall remain valid and enforceable, and the controlling authority shall be empowered to modify such invalid or unenforceable provisions to the extent necessary to make them valid and enforceable to the maximum extent possible. By signing below, Range Operator, acting through an authorized representative with authority to bind the Range Operator, agrees to all the foregoing terms and conditions.
